

License Agreement for Campaign ToolBox

Important - Read this carefully before ordering or downloading or installing the software!

This software license agreement is provided to you before you download the software or order the software. By downloading the software or ordering the software or installing the software, you have indicated your acceptance of all of the terms and conditions of this license agreement. If you do not agree with all of the terms of this agreement, you must not order or install the software.

This software is Licensed, Not Sold. The Campaign ToolBox software is licensed according to the terms of the following agreement:

1. License

Adjutant Software (hereinafter referred to as "Vendor"), hereby grants Licensee, a limited, non-transferable license to use Campaign ToolBox software (hereinafter referred to as "Software").

2. Terms and Duration of this License

The license to use the Software begins on the day you download the software or open the media package, and expires on the expiration date shown on your invoice and displayed by the software, or until you return the original media and destroy any copies you may have made, whichever comes first. The Software will not accept any data input with a date after the expiration date of this license. This license gives you certain limited rights to use the Software. You do not become an owner of, and Vendor retains title to the Software. You agree to use reasonable efforts to protect the Software from unauthorized use, reproduction, distribution, or publication.

3. Permitted uses

Campaign ToolBox is licensed to a single user. That user may be a political campaign, a political committee, a political consultant, an accounting firm, a party executive committee, or other similar entity.

Except as noted, you may use multiple copies of Campaign ToolBox within the reasonable scope of duties of the Licensee. For example, a campaign may install a copy on the Treasurer's computer, and another on the Candidate's computer, and still another on the Campaign Manager's computer. This applies only to licenses purchased at the full price. Licenses purchased as "Additional Reporting Entities" may only be used on the computer on which it was originally installed and may not be transferred to another computer.

4. Uses NOT Permitted

You may not load the software on another computer with the intent to use the software for purposes outside the reasonable scope of the entity to whom the software is licensed or to avoid payment of the registration fee.

Use by anyone other than the Licensee or the Licensee's authorized agent is prohibited.

You may not alter, decompile, disassemble, or reverse engineer the Software.
